Newfoundland Waiting List Policy

If you would like to join our waiting list, there is an annual fee of \$75.00. This will secure you a position on the list from January 1st to December 31st of each year. If you are added to the list after June 1st, your first annual fee will be prorated to \$50.00, increasing to the full amount of \$75.00 for the next annual period should you wish to remain on the list. There are no refunds or credits and this fee does not apply to the cost of the puppies. A copy of the Wolf Creek Purchase Agreement and Puppy Care Guidelines will be posted on the website. We strongly recommend that you review these documents prior to the payment of your waiting list fee. Please note, Wolf Creek Newfoundlands sells all puppies as pets and not for breeding purposes.

If you are interested in being added to our waiting list, please email info@newfpuppies.com. After receiving your email, we will give you instructions for making your payment and can answer any questions you have, as well as let you know how many people will be on the list ahead of you.

Payment via Paypal or check is due by January 1st in order to maintain your position on the waiting list. If payment is not received by January 10th, you will be removed from the list. If you wish to rejoin the list, you will be placed at the bottom of the list upon receipt of payment by Wolf Creek Newfoundlands (WCN).

Upon WCN's receipt of the initial waiting list payment, each client will be assigned an account number which will be used to show your placement on the waiting list. The list will be updated each month and/or per litter, and will be on the WCN website where you can view your position on the list. This list will only contain the account numbers issued by WCN. No personal information will be posted.

Upon each new litter, pictures of the puppies along with their names and genders will be emailed to those highest on the list, corresponding to the number of puppies in that litter. Those who are interested will have 5 days to respond and must list the puppy and/or puppies they are willing to accept in order of preference. You may bypass as many litters as you wish, provided your annual fees are current.

Example: If a litter consists of 5 puppies - A, B, C, D and E. The purchaser chooses C, A and D as their order of preference, based on WCN photos and the purchaser's color and gender preference. If a client higher up on the waiting list has chosen puppy C, WCN will offer you puppy A. If none of your choices remain, and only puppy B is left, WCN will notify you that none of your choices are available and you would remain on the list for future litters.

The current cost (subject to change) of each puppy is \$2,200.00-\$2,500 plus tax. Once a puppy has been offered by WCN and accepted by the purchaser, a non-refundable deposit of \$300.00 will be required to secure the puppy. Payment by check, credit card, Paypal or cashier's check

will be due in full by the time the puppy turns seven week old. Payment must clear before buyer takes possession of the puppy. Typically, we will also offer a discount for cash/check payments.

The breakdown of cost: Cost of the puppy (subject to change): \$2,200.00 less the \$300.00 non-refundable deposit leaves a balance due of \$1,900.00 plus tax (based on Shasta County at 7.25%) which is \$159.50.

Shipping: All arrangements must be approved by Wolf Creek Newfoundland in advance. All shipping costs must be paid and arrangements made at the beginning of the puppy's 7th week and is the sole responsibility of the purchaser. If shipping by air, purchaser is solely responsible for any shipping requirements and/or costs, as well as the purchase of a health certificate (required by most airlines). WCN will obtain the health certificate on behalf of the purchaser. If transportation to the airport by WCN is needed, a trip-fee will also be required.

Please note: Due to USDA regulations, WCN is unable to sell puppies "sight unseen." Purchasers, or a proxy of their choice, must see the puppy they plan to purchase in person prior to WCN shipping the puppy to you.

Crates: If a crate is needed, WCN will purchase the crate after payment for the cost of the crate is received from the purchaser.

Notifications and emails:

Generally this is the sequence of communication that will take place, but may vary depending on circumstances.

1st emailing: This email will be sent out upon knowledge of a pregnancy.

2nd emailing: This email will be sent out upon knowledge of how many puppies WCN believes will be delivered.

3rd emailing: This email will be sent out when the puppies are two weeks old. At this time, WCN will be in the process of registering the litter with either AKC or UKC.

4th emailing: This email will be sent when the puppies are 5 weeks old. An offer will be made to the purchaser according to list order and the number of puppies in the litter. A notification of commitment will be required of the purchaser. WCN will send purchaser an Intent to Purchase form which must be signed and returned along with the deposit.

5th emailing: This email will be sent when the puppies are 6 weeks old and will contain a Notice of Final Payment (if not yet paid) and a Purchase Agreement containing both the puppy's and purchaser's information. WCN will also indicate the week that pick up is required.

Puppy Pickup:

The date and time of puppy pick up must be set by **appointment only**. WCN must be notified 72 hours in advance of any changes. Pick up times must be between 10:00 AM and 7:00 PM. Please remember that our breeding facility is located on school property and our schedules must be set to accommodate staff and students. Please try to arrive on time for your

appointment. For your convenience, we will try to include 2 weekends in the time period given to pick up your puppy.

Extended Puppy Boarding:

If you are unable to pick up your puppy within the scheduled pickup time frame given by WCN, you will be charged \$25.00 per day for every day the puppy remains in our care. We generally release the puppies at 8 weeks old. It is very important for puppy/owner bonding purposes that the puppy be taken to their new homes as soon as possible.

NOTE: Purchasers are responsible for remaining up to date on WCN emails and are encouraged to add info@newfpuppies.com to their email contacts list and regularly check their SPAM folders.

*WCN reserves the right to withhold a puppy or puppies from any litter.

Lastly, we would like to remind you that all proceeds go towards the program which supports and cares for high risk victims and victims of human trafficking.
